- I understand that Capgemini SE has set up, with the assistance of my employer, an
  offer of Capgemini shares reserved for its employees, through the compartment
  "ESOP Leverage P 2022" of the FCPE "ESOP Capgemini". Under this offer, personal
  data provided in this revocation order shall undergo electronic data processing by:
- Capgemini SE, having its corporate office at 11 rue de Tilsitt, 75017 Paris, France, as data controller for communicating and collecting subscriptions and revocations from employees, and centralising subscriptions and revocations;
- Amundi ESR, having its corporate office at 91-93 boulevard Pasteur 75015 Paris France, as data controller for registrar holding and unit account holding of assets subscribed within the framework of the relevant IGSP and FCPE.

Processing of my personal data included in this revocation order shall be implemented on the basis of performance of a contract through the submission of this order.

The data processing is subject to the French Law n°78-17 of 6 January 1978 on data processing, data files and individual liberties and the EU Regulation on Data Protection (2016/679) of the European Parliament and of the Council of 27 April 2016 on the protection of individuals with regards to the processing of personal data and free movement of such data.
